



This document describes the Voucher Download file format.

File Description

Each column in the Voucher Download file is separated by a pipe character and the first line of the file contains the column descriptions with the pipe delimiters. Here are the data definitions of the columns:

TrusteeName	Trustee Full Name
TrusteeCity	Trustee City
TrusteeState	Trustee State
CaseNumber	NDC Case Number
Deb1LastName	Debtor 1 Last Name
Deb1FirstName	Debtor 1 First Name
Deb1SSN	Debtor 1 SSN (may be partially redacted)
Deb2LastName	Debtor 2 Last Name
Deb2FirstName	Debtor 2 First Name
Deb2SSN	Debtor 2 SSN (may be partially redacted)
CaseStatus	Case Status
ClaimNumber	Claim Number (not court claim number)
AccountNumber	Account Number (may be partially redacted)
ChkDate	Check Date
CheckNo	Check Number
CheckAmount	Check Amount
ClaimLevel	Claim Level payout
ClaimType	Claim Type (secured, unsecured, etc)
Comment	Trustee comments for the claim
CredNo	Trustee creditor number
CredName	Trustee creditor name
PaymentType	Trustees payment description
